

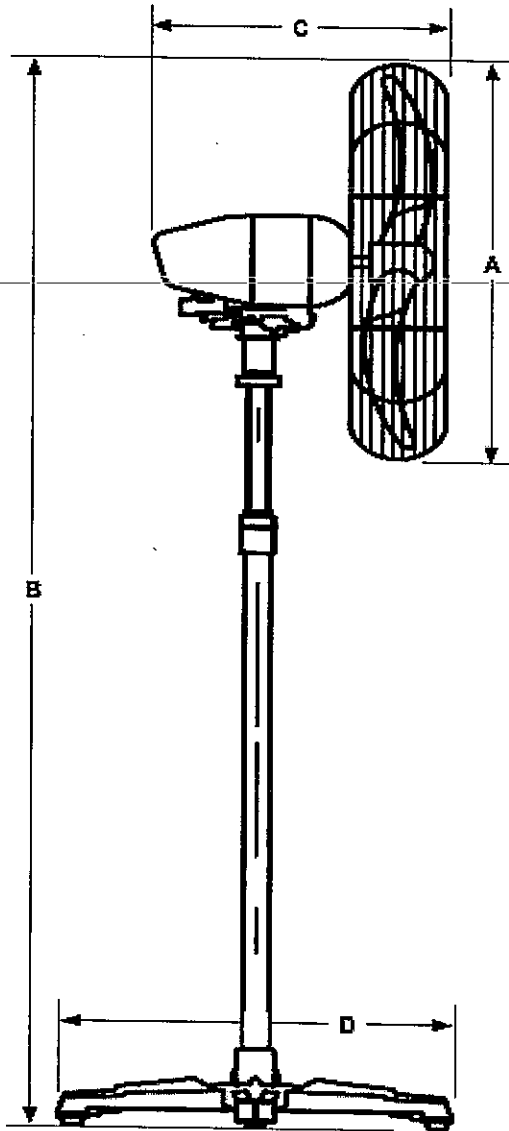

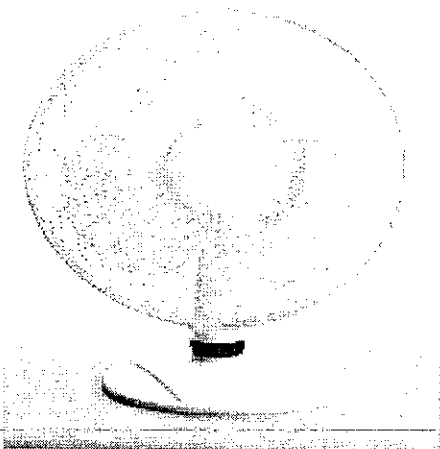

1. PURPOSE

To request for funding for the procurement of fans for P. Block at R.K. Khan Hospital.

2. BACKGROUND

- 2.1. The P. Block building was commissioned in November 2015 with a functional central air conditioning unit. However, the unit had failed due to corrosion in February 2018.
- 2.2. The P.Block Central air conditioning plant is essential to ensure that the clinics have adequate air-conditioning and ventilation. The design of the building is not conducive to cross ventilation and is therefore air-conditioning dependent. The clinic is a high traffic area, with approximately 700 outpatients daily. Presently, there is inadequate ventilation and staff and patients are exposed to possible infection and extreme humid conditions.
- 2.3. The areas affected are indicated in the attached floor plans.
- 2.4. The unit at P. Block is anticipated to be repaired in March 2019.
- 2.5. The staff are discontent with the working environment have taken the matter to Labour Relations.

3. MOTIVATION

- 3.1. The fans (60) are required to ensure that the P. Block have adequate ventilation for patients and staff.
- 3.2. After the central air conditioning unit is repaired in March 2019, the procured fans will not be seen as wasteful expenditure as they can be used in other areas should similar circumstances arise.



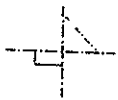

Ground floor dental P-Block

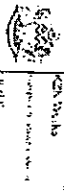

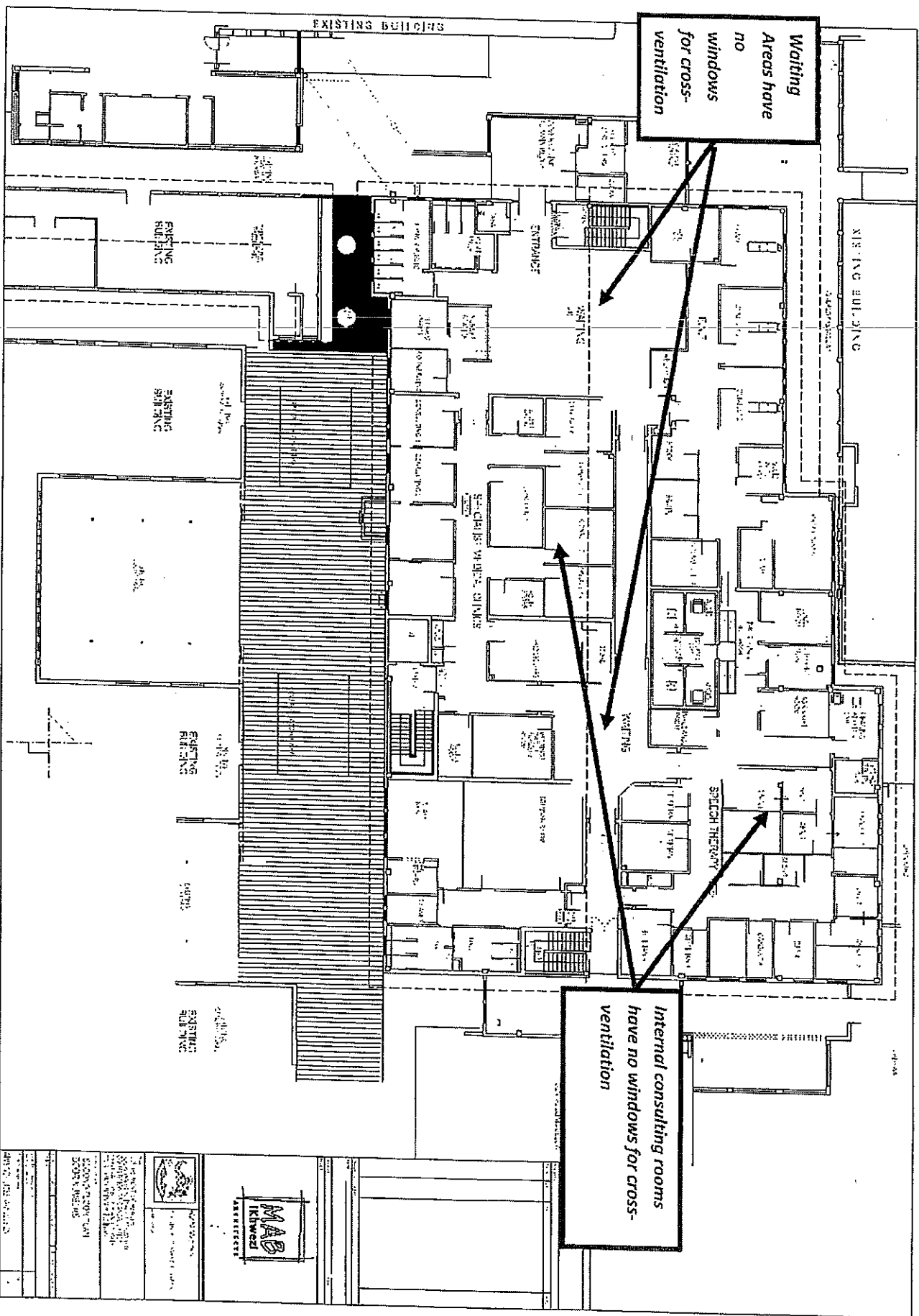

1. AMENDMENT OF CONTRACT

1.1. Any amendment to or renunciation of the provisions of the contract shall at all times be done in writing and shall be signed by both parties.

2. CHANGE OF ADDRESS

2.1. Bidders must advise the Department of Health (institution where the offer was submitted) should their address (*domicilium citandi et executandi*) details change from the time of bidding to the expiry of the contract.

3. GENERAL CONDITIONS ATTACHED TO THIS QUOTATION

- 3.1. The institution is under no obligation to accept the lowest or any quote.
- 3.2. The price quoted must include VAT (if VAT vendor). However, it must be noted that the department reserves the right to evaluate all quotations excluding VAT as some bidders may not be VAT vendors.
- 3.3. The bidder must ensure the correctness & validity of quote:
 - (i) *that the price(s), rate(s) & preference quoted cover all for the work/item (s) & accept that any mistakes regarding the price (s) & calculations will be at the bidder's risk*
- 3.4. The bidder must accept full responsibility for the proper execution & fulfilment of all obligations conditions devolving on under this agreement, as the Principal (s) liable for the due fulfilment of this contract.

6. STATEMENT OF SUPPLIES AND SERVICES

- 6.1. The contractor shall, when requested to do so, furnish particulars of supplies delivered or services executed. If he/she fails to do so, the Department may, without prejudice to any other rights which it may have, institute inquiries at the expense of the contractor to obtain the required particulars.

7. SUBMISSION AND COMPLETION OF SBD 6.1

- 7.1. Should a bidder wish to qualify for preference points they must complete a SBD 6.1 document. 12. TERMINATION FOR DEFAULT

- (j) **"rand value"** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
