1. AMENDMENT OF CONTRACT

1.1. Any amendment to or renunciation of the provisions of the contract shall at all times be done in writing and shall be signed by both parties.

2. CHANGE OF ADDRESS

2.1. Bidders must advise the Department of Health (institution where the offer was submitted) should their address (domicilium citandi et executandi) details change from the time of bidding to the expiry of the contract.

3. GENERAL CONDITIONS ATTACHED TO THIS QUOTATION

- 3.1. The institution is under no obligation to accept the lowest or any quote.
- 3.2. The price quoted must include VAT (if VAT vendor). However, it must be noted that the department reserves the right to evaluate all quotations excluding VAT as some bidders may not be VAT vendors.
- 3.3. The bidder must ensure the correctness & validity of quote:
 - that the price(s), rate(s) & preference quoted cover all for the work/item (s) & accept that any mistakes regarding the price (s) & calculations will be at the bidder's risk
- 3.4. The bidder must accept full responsibility for the proper execution & fulfilment of all obligations conditions devolving on under this agreement, as the Principal (s) liable for the due fulfilment of this contract.

6. STATEMENT OF SUPPLIES AND SERVICES

6.1. The contractor shall, when requested to do so, furnish particulars of supplies delivered or services executed. If he/she fails to do so, the Department may, without prejudice to any other rights which it may have, institute inquiries at the expense of the contractor to obtain the required particulars.

7. SUBMISSION AND COMPLETION OF SBD 6.1

7.1. Should a bidder wish to qualify for preference points they must complete a SBD 6.1 document. Failure by a bidder to provide all relevant information required, will result in such a bidder not being considered for preference point's allocation. TECHNICAL SPECIFICATION

Clause 1
Outer Sleeve – 430 brushed Stainless Steel, mirror finish with swagged top and bottom edges.
The entire unit is to be manufactured from a heavy duty stainless steel. No plastic parts in the mechanism will be accepted.

Inner Sleeve – 430 brushed Stainless Steel, mirror finish with swagged top, pressed bottom and a 304 brushed Stainless Steel wire handle.
Fully washable in an Autoclave or Pressure Cleaner.
Durable plastic 4 mm lugs x 3 fitted to the underside rim of the outer sleeve to prevent the floors being scratched.
Robust 304 brushed Stainless Steel pedal, rear lid hinge and rod assembly.
Pressed lid in 430 brushed Stainless Steel.
