## SPECIAL CONTRACT CONDITIONS OF QUOTATIONS

## 1. AMENDMENT OF CONTRACT

1.1. Any amendment to or renunciation of the provisions of the contract shall at all times be done in writing and shall be signed by both parties.

#### 2. CHANGE OF ADDRESS

2.1. Bidders must advise the Department of Health (institution where the offer was submitted) should their address (domicilium citandi et executandi) details change from the time of bidding to the expiry of the contract.

#### 3. GENERAL CONDITIONS ATTACHED TO THIS QUOTATION

- 3.1. The institution is under no obligation to accept the lowest or any quote.
- 3.2. The price quoted must include VAT (if VAT vendor). However, it must be noted that the department reserves the right to evaluate all quotations excluding VAT as some bidders may not be VAT vendors.
- 3.3. The bidder must ensure the correctness & validity of quote:
  - (i) that the price(s), rate(s) & preference quoted cover all for the work/item (s) & accept that any mistakes regarding the price (s) & calculations will be at the bidder's risk
- 3.4. The bidder must accept full responsibility for the proper execution & fulfilment of all obligations conditions devolving on under this agreement, as the Principal (s) liable for the due fulfilment of this contract.
- 3.5. This quotation will be evaluated based on the 80/20 points system, specification & correctness of information. All required documentation must be completed in full and submitted.
- 3.6. Offers must comply strictly with the specification.
- 3.7. Only offers that meet or are greater than the specification will be considered.
- 3.8. Late quotes will not be considered.
- 3.9. Expired product/s will not be accepted. All products supplied must be valid for a minimum period of six months.
- 3.10. A bidder not registered on the Central Suppliers Database or verification has failed will not be considered.

## 8. STATEMENT OF SUPPLIES AND SERVICES

8.1. The contractor shall, when requested to do so, furnish particulars of supplies delivered or services executed. If he/she fails to do so, the Department may, without prejudice to any other rights which it may have, institute inquiries at the expense of the contractor to obtain the required particulars.

# 9. SUBMISSION AND COMPLETION OF SBD 6.1

9.1. Should a bidder wish to qualify for preference points they must complete a SBD 6.1 document. Failure by a bidder to provide all relevant information required, will result in such a bidder not being considered for preference point's allocation. The preferences applicable on the closing date will be utilized. Any changes after the closing date will not be considered for that particular quote.

#### 10. TAX COMPLIANCE REQUIREMENTS

#### 13. PENALTIES

13.1. If at any time during the contract period, the service provider is unable to perform in a timely manner, the service provider must notify the institution in writing/email of the cause of and the duration of the delay. Upon receipt of the notification, the institution should evaluate the circumstances and, if deemed necessary, the institution may extend the service provider's time for performance.

In the event of delayed performance that extends beyond the delivery period, the institution is entitled to purchase commodities of a similar 13.2. quantity and quality as a substitution for the outstanding commodities, without terminating the contract, as well as return commodities

delivered at a later stage at the service provider's expense.

Alternatively, the institution may elect to terminate the contract and procure the necessary commodities in order to complete the contract. 13.3. In the event that the contract is terminated the institution may claim damages from the service provider in the form of a penalty. # Specification for Eradication and Control of Pests and Vermin Gamalakhe Clinics

- 1. Material Safety Data Sheets will be required from the successful service provider.
- 2. A full treatment of all areas within the institution monthly for a period of 24 months.
- 3. If, between the monthly services infestation of any type (rats, cockroaches, moths, larvae and fish moths or any other pests) becomes apparent, the service provider will provide the necessary corrective treatment to satisfaction at no additional cost to the institution. It is also recommended that the poison types be alternated at least every third service as pests seems to become immune to the poison after repeated use.
- 4. The service to include birds lice treatment/ fumigation

# NB. The service will exclude removal of bees, treatment of termites/woodborers and white ants only.

- 5. The contractor must show the amount for each month.
- 6. The total quotation price must be for 24 months.
- 7. The contractor must re-install all bait stations that are loose or removed from the wall.
- 8. The contractor must number all bait stations in numerical order with oil paint.
- 9. A register must be provided with the number of the bait station and the area the bait station is located.
- 10. It is the responsibility of the contractor to maintain bait stations i.e. in good order and attached to the wall.
- 11. All bait stations must be replenished with poison at every service.
- 12. All manholes within the institution (including Nurses Homes) must be opened and sprayed.
- 13. The Waste Center and all plant rooms in the institution must be sprayed at every service. The keys can be obtained from the Maintenance Department.
- 14. All servicing is to be carried out during normal working hours and with the least inconvenience to the wards, departments and patients. The successful service provider must liaise with departments such as Operating Theatre and Kitchen regarding their most convenient days and times.
- 15. The successful service provider shall submit a schedule of proposed dates for the twelve months prior to commencing the service.
- 16. On every service carried out, the service provider will report first to Supply Chain Management and complete the contractors register.
- 17. After every service a signed schedule by authorized officials of all the areas serviced must be submitted together with the invoice for that month. Failure to comply herewith will result in payment being delayed or withheld.

- 18. Proof of registration with the pest control board and at least 2 references with contact numbers to be submitted with the tender documents.
- 19. Failure to comply with the above will lead to your tender document being disqualified
