## SPECIAL CONTRACT CONDITIONS OF QUOTATIONS

### 1. AMENDMENT OF CONTRACT

- 1.1. Any amendment to or renunciation of the provisions of the contract shall at all times be done in writing and shall be signed by both parties.

### 2. CHANGE OF ADDRESS

- 2.1. Bidders must advise the Department of Health (institution where the offer was submitted) should their address (*domicilium citandi et executandi*) details change from the time of bidding to the expiry of the contract.

### 3. GENERAL CONDITIONS ATTACHED TO THIS QUOTATION

- 3.1. The institution is under no obligation to accept the lowest or any quote.
- 3.2. The price quoted must include VAT (if VAT vendor). However, it must be noted that the department reserves the right to evaluate all quotations excluding VAT as some bidders may not be VAT vendors.
- 3.3. The bidder must ensure the correctness & validity of quote:
- (i) *that the price(s), rate(s) & preference quoted cover all for the work/item (s) & accept that any mistakes regarding the price (s) & calculations will be at the bidder's risk*
- 3.4. The bidder must accept full responsibility for the proper execution & fulfilment of all obligations conditions devolving on under this agreement, as the Principal (s) liable for the due fulfilment of this contract.
- 3.5. This quotation will be evaluated based on the 80/20 points system, specification & correctness of information. All required documentation must be completed in full and submitted.
- 3.6. Offers must comply strictly with the specification.
- 3.7. Only offers that meet or are greater than the specification will be considered.
- 3.8. Late quotes will not be considered.
- 3.9. Expired product/s will not be accepted. All products supplied must be valid for a minimum period of six months.
- 3.10. A bidder not registered on the Central Suppliers Database or verification has failed will not be considered.
- 3.11. All delivery costs must be included in the quote price, for delivery at the prescribed destination.
- 3.12. Only firm prices will be accepted. Such prices must remain firm for the contract period. Non-firm prices (including rates of exchange variations) will not be considered.
- 3.13. In cases where different delivery points influence the pricing, a separate pricing schedule must be submitted for each delivery point.
- 3.14. In the event of a bidder having multiple quotes, only the cheapest according to specification will be considered. Furthermore a verification will be done to identify if bidders have multiple companies and are quoting (cover-quoting) for this bid. In such instances only the cheapest bid according to specification will be considered.

### 4. SPECIAL INSTRUCTIONS AND NOTICES TO BIDDERS REGARDING THE COMPLETION OF THIS QUOTATION.

- 4.1. Unless inconsistent with or expressly indicated otherwise by the context, the singular shall include the plural and vice versa and with words importing the masculine gender shall include the feminine and the neuter.
- 4.2. Under no circumstances whatsoever may the quotation/bid forms be retyped or redrafted. Photocopies of the original bid documentation may be used, but an original signature must appear on such photocopies.
- 4.3. The bidder is advised to check the number of pages and to satisfy himself that none are missing or duplicated.
- 4.4. Quotation submitted must be complete in all respects.
- 4.5. Any alteration made by the bidder must be initialled.
- 4.6. Use of correcting fluid is prohibited
- 4.7. Quotation will be opened in public as soon as practicable after the closing time of quotation.
- 4.8. Where practical, prices are made public at the time of opening quotations.
- 4.9. If it is desired to make more than one offer against any individual item, such offers should be given on a photocopy of the page in question. Clear indication thereof must be stated on the schedules attached.

### 5. SPECIAL INSTRUCTIONS REGARDING HAND DELIVERED QUOTATIONS

- 5.1. Quotation shall be lodged at the address indicated not later than the closing time specified for their receipt, and in accordance with the directives in the quotation documents.
- 5.2. Each quotation shall be addressed in accordance with the directives in the quotation documents and shall be lodged in a separate sealed envelope, with the name and address of the bidder, the quotation number and closing date indicated on the envelope. The envelope shall not contain documents relating to any quotation other than that shown on the envelope. If this provision is not complied with, such quotations/bids may be rejected as being invalid.
- 5.3. All quotations received in sealed envelopes with the relevant quotation numbers on the envelopes are kept unopened in safe custody until the closing time of the quotation/bids. Where, however, a quotation is received open, it shall be sealed. If it is received without a quotation/bid number on the envelope, it shall be opened, the quotation number ascertained, the envelope sealed and the quotation number written on the envelope.
- 5.4. A specific box is provided for the receipt of quotations, and no quotation found in any other box or elsewhere subsequent to the closing date and time of quotation will be considered.



### **13. PENALTIES**

- 13.1. If at any time during the contract period, the service provider is unable to perform in a timely manner, the service provider must notify the institution in writing/email of the cause of and the duration of the delay. Upon receipt of the notification, the institution should evaluate the circumstances and, if deemed necessary, the institution may extend the service provider's time for performance.
- 13.2. In the event of delayed performance that extends beyond the delivery period, the institution is entitled to purchase commodities of a similar quantity and quality as a substitution for the outstanding commodities, without terminating the contract, as well as return commodities delivered at a later stage at the service provider's expense.
- 13.3. Alternatively, the institution may elect to terminate the contract and procure the necessary commodities in order to complete the contract. In the event that the contract is terminated the institution may claim damages from the service provider in the form of a penalty. The service provider's performance should be captured on the service provider database in order to determine whether or not the service provider should be awarded any contracts in the future.
- 13.4. If the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance.

### **14. TERMINATION FOR DEFAULT**

- 14.1. The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:
  - (i) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract,
  - (ii) if the supplier fails to perform any other obligation(s) under the contract; or
  - (iii) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 14.2. In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services.
- 14.3. Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.

## **SPECIFICATION FOR LAUNDRY HANDLING SERVICE FOR KING EDWARD VIII HOSPITAL**

### **1. Description of Required Service**

- 1.1. Provision of laundry handling services for King Edward Viii Hospital (KEH) at KwaZulu Central Provincial Laundry (KCPL). The location of the main service may change to another venue within 40km of the KCPL.
- 1.2. Service shall be inclusive of laundry service quality and quantity control checks. Regular reports for such shall be required with admin/supervisor officials placed at both KEH & KCPL.
- 1.3. The service provider must provide all the general workers with uniforms, safety shoes and all other necessary personal protective equipment. This as physically soiled and biologically infected laundry shall be handled.
- 1.4. A minimum amount of 4500kg of laundry shall have to be handled and processed on a daily basis, utilising the machinery of the KwaZulu Central Provincial Laundry. Thus 13 general workers and supervisors shall be recommended as part of the service contract.
- 1.5. The general worker services shall be required to be operational for 8hrs day and 4 days a week. Monday to Thursday inclusive of holidays, from 07:30 to 16:30. The supervisor service shall be required for 8hrs a day for 5 days a week.
- 1.6. This service shall be for a duration of 6months

### **2. The Schedule of Tasks and Staff Allocation**

#### **2.1. *Key tasks to be executed by General Workers***

- 2.1.1. Sorting of sluiced linen and preparing for loading to the washing machine.
- 2.1.2. Loading of sluiced and sorted linen onto the washing machine.
- 2.1.3. Receiving dry linen from the tumble drier.
- 2.1.4. Separating and sorting of dry linen.
- 2.1.5. Feeding of dry linen onto the roller iron.
- 2.1.6. Receiving and folding of ironed linen from the roller iron.
- 2.1.7. Packing of folded linen from the roller iron.
- 2.1.8. Hand folding of clean linen (e.g. blankets/bedspreads)

2.1.9. Any other general work assigned by the supervisor

## **2.2. The allocation of General Workers**

2.2.1. The general workers will be placed at KwaZulu Central Provincial Laundry.

2.2.2. In the event of mechanical downtime/malfunction, the general workers may be placed at another centre (within 30km of KCPL) to be able to continue with general work as directed by KEH Management.

2.2.3. The timing of lunch and tea breaks to be negotiated to KEH management.

2.2.4. Hours of work attendance may be subject to changes

2.2.5. It is compulsory for the service provider to ensure that the total number of staff is on duty during the stipulated working hours. Non availability of staff will be considered a breach of contract

## **2.3. Key responsibilities to be executed by the 2 supervisors**

2.3.1. To liaise with relevant KEH & KCPL stakeholders on the delivery and pick-up arrangements of laundry

2.3.2. To supervise the work and support done by general workers

2.3.3. To provide the KEH Management with a signed copy of allocation /attendance register.

2.3.4. To provide quality control checks on the work done by general workers

2.3.5. To compile service admin reports as per the KEH management requirements

2.3.6. To compile admin reports using a computer provided KEH Management

## **2.4. The allocation of the 2 supervisors**

2.4.1. King Edward Hospital shall be their head quarters

2.4.2. Shall regularly visit KwaZulu Central Provincial Laundry

## **3. Other General Conditions & Requirements**

3.1.1. It is compulsory for the service provider to ensure that the total number of staff is on duty during the stipulated working hours. The contractor must arrange at own cost relievers for biological-/tea-breaks, lunch, leave and absenteeism of any kind. Non availability of staff during the stipulated service times will be considered a breach of contract.

3.1.2. The service provider must provide all the general works with uniforms, safety shoes, household gloves and ID badges.

3.1.3. General Worker must be appropriately dressed all the times and ensure that they display their ID/name badges at all times.

- 3.1.4. The general worker must at all times be courteous and polite to other staff members,
- 3.1.5. The general worker will be based at KwaZulu Central Provincial Laundry and shall provide laundry services and other general services.
- 3.1.6. The general worker may also be required to provide services at other centres within 30km at own cost or contractor`s cost at the request of KEH
- 3.1.7. The supervisor/team leader of the general workers shall liaise during normal working hours with King Edward VIII Hospital`s contract manager and on public holidays to the laundry manager or supervisor on any issue concerning the general work/laundry services
- 3.1.8. The required number of staff must be on duty at all times
- 3.1.9. The service provider must a member of the bargaining council. Company must be registered with the department of labour.
