- 1.2 The department reserves the right to evaluate all quotations excluding VAT as some bidders may not be VAT vendors.
- 1.3 The bidder must ensure the correctness & validity of quote: that the price(s), rate(s) & preference quoted cover all for the work/item(s) & accept that any mistakes regarding the price (s) & calculations will be at the bidder's risk.
- 1.4 The bidder must accept full responsibility for the proper execution & fulfilment of all obligations conditions devolving on under this agreement, as the Principal (s) liable for the due fulfillment of this contract.
- 1.5 This quotation will be evaluated specification & correctness of information.
- 1.6 Only offers that comply with or greater than specification will be considered.
- 1.7 Late quotes will not be considered.
- 1.8 All products supplied must be valid for a minimum period of six months.
- 1.9 A bidder not registered on the Central Suppliers Database or verification has failed will not be considered.
- 1.10 All delivery costs must be included in the quote price, for delivery at the prescribed destination.
