SCOPE OF CONTRACT

The specification calls for the supply and installation of 6 pairs Heavy Duty double Traffic Doors for Ward AB1 and Main Kitchen

7. DETAILED SPECIFICATION

- **2.1.** The doors that are to be supplied and installed shall be the Model SR 9000 manufactured by Apex Industries or equivalent. Catalogue or sample must be submitted for prior approval.
- **2.2.** The doors must be Insulated impact swing doors complete with vision panels, fully gasketed lower hinge guards, painted mild steel frame, black bumpers both sides, beige in colour.
- 2.3. The doors at the Main Kitchen area must be provided with a locking facility.
- **2.4.** The width of the openings for the Main Kitchen area where doors are to be installed is **1610mm** and the height **2000mm**.
- 2.5. The width of the openings for Ward AB1 where doors are to be installed is 1500mm and the height 2150mm.
- 2.6. The installation shall be durable and reliable to a safe standard.
- 2.7. The doors shall be cream in colour and include viewing panels which are made of 1/8" scratch resistant polycarbonate transparent sheet 410mmW x 510mm H.
- **2.8.** The doors shall be suspended on a galvanized steel frame if required and is to be supplied by the manufacturer/ installer.
- 2.9. All processes in the preparation of the installation shall be undertaken by the contractor.
- 2.10. All tampered surfaces shall be restored to an acceptable standard.
