

**INSTALLATION OF PARTITIONS, DOORS AND DUTY COUNTER FOR COVID-19
AT R. K. KHAN HOSPITAL**

1. SCOPE OF CONTRACT

This specification calls for the supply and installation of a partitions, doors and duty counter at the existing ward P5 as per the Bill of Quantities at R K Khan Hospital.

2. GENERAL SPECIFICATION

2.1.1. Partitions:

2.1.2. The dimensions of the cubicle to be installed as per the bill of quantities.

2.1.3. 12mm Plaster Board tapered edge dry wall partitioning is to be used, the base is to be sealed with sound insulation under the floor track for infection control with cavity batt insulation. All butt joints on plaster board to be covered with 50mm fibre tape and made good with quick dry skimming compound ready for painting.

2.1.4. Finish to be painted with a SABS approved acrylic paint. Recommend a fine stipple coat to avoid seeing skimming of junctions.

2.1.5. Insulation in cavities to conform to Class 1 fire index with a minimum of 50mm thick.

2.1.6. Studding and tracks for partitioning to be galvanized steel and wall thickness to be 76mm finished product.

2.1.7. Aluminium skirting shall be fixed at the base of the partition cubicle, minimum 75mm in height both inside and outside. The skirting shall be fixed with a contact adhesive directly to the unpainted gypsum surface and additionally be riveted to the supporting frame.

2.1.8. The cubicle partition walls in the Ward shall fixed and boarded up to the existing ceiling level.

2.1.9. The partition section, to be fixed to ceiling level, consists of 1 double swing door opening, with doors capable of swing both inwards and outwards.

2.1.10. Each door leaf shall be fitted with 1 aluminium-framed glass with minimum opening sizes of 400mm (height) x 600mm (width), 1.5 metre above floor level. All glass shall be 6mm toughened or armour-plated glass.

2.1.11. Both doors shall be solid core timber, 40mm in thickness, with rebated meeting stiles to ensure that they form a seal. Rubber gasket seals must be fixed to door contact points to minimize or


prevent airflow. All doors must be fitted with weather strip type footing.

- 2.1.12.** All doors to patient treatment areas are to be a minimum clear width of 1,000mm clad with Grade 304 stainless steel lining to be 1,2mm thick x 1,1m high generally, to entrance face, returning on lock side of door.
- 2.1.13.** Both door leaves shall be mounted with a minimum of 3 hinges.
- 2.1.14.** Push plates to be 350mm (length) x 150mm (width) fixed to both sides of door with dual aluminium U-type pull handles on the opening side.
- 2.1.15.** Rebates in frames are required to accommodate the door thickness and the stainless steel plates and returns.

2.2. Joinery specification (cupboards and tops- Station)

- 2.2.1.** Doors, drawer fronts and cupboard carcasses to be constructed out of 18mm Melamine faced particle board with 2mm high impact edging or 18 x 10mm hard wood edging. "Supa Wood" is only permitted for internal shelving, and not for cupboard construction.
- 2.2.2.** Worktops in general to be 32mm solid post formed Formica on "V313 (HMR)" (High Moisture Resistant) particle board.
- 2.2.3.** The base of the structure shall be 22mm marine ply board and trimmed with impact edging to match the colour of the cupboards.
- 2.2.4.** The height of the counter top shall be a maximum of 750mm above floor level.
- 2.2.5.** The duty station shall comprise of 2 x 450mm wide, 5 draw units and 2 x 450mm width pigeon hole units.
- 2.2.6.** The counter top shall feature a Perspex screen, 1.2 metres above the counter top, secured with an aluminium frame.
- 2.2.7.** The Duty Station Floor shall be constructed with 50mm thickness solid treated pine support frame. The floor board must be 21 to 22mm marine plywood fixed to the supporting frame. The floor shall be covered in PVC backed 920 g/sq m – 980 g/sq m sheet carpet, minimum thickness of 6mm.

3. CONDITIONS OF CONTRACT

- 3.1. Contractors are advised to visit the site and take specific measurements before submitting quotes.
- 3.2. Storage of all materials will be at contractors' risk.
- 3.3. All necessary safety precautions are to be observed. Kindly note that buildings are occupied and all risks are for the contractors' accountability.
- 3.4. The successful bidder must produce a safety file prior to commencement of work.
- 3.5. The duration of the works is to be 2 weeks from the receipt of the official order.
- 3.6. All works is to be guaranteed for 12 months from date of completion.
- 3.7. All materials used shall be S.A.B.S. approved as per the Department of Health specifications.
- 3.8. All works carried out is to be to the entire satisfaction of the CEO or his/ her appointed representative.
- 3.9. All building rubble and debris must be disposed off site as it accumulates
- 3.10. Contractors must be registered with the C.I.D.B. with a minimum grading of 1 GB and Central Suppliers' database.
- 3.11. Quotations are to be deposited at the Hospital Main Entrance, Security.

1. AMENDMENT OF CONTRACT

- 1.1. Any amendment to or renunciation of the provisions of the contract shall at all times be done in writing and shall be signed by both parties.

2. CHANGE OF ADDRESS

- 2.1. Bidders must advise the Department of Health (institution where the offer was submitted) should their address (*domicilium citandi et executandi*) details change from the time of bidding to the expiry of the contract.

3. GENERAL CONDITIONS ATTACHED TO THIS QUOTATION

- 3.1. The institution is under no obligation to accept the lowest or any quote.
- 3.2. The price quoted must include VAT (if VAT vendor). However, it must be noted that the department reserves the right to evaluate all quotations excluding VAT as some bidders may not be VAT vendors.
- 3.3. The bidder must ensure the correctness & validity of quote:
- (i) *that the price(s), rate(s) & preference quoted cover all for the work/item (s) & accept that any mistakes regarding the price (s) & calculations will be at the bidder's risk*
- 3.4. The bidder must accept full responsibility for the proper execution & fulfilment of all obligations conditions devolving on under this agreement, as the Principal (s) liable for the due fulfilment of this contract.
- 3.5. This quotation will be evaluated based on the 80/20 points system, specification & correctness of information. All required documentation must be completed in full and submitted.
- 3.6. Offers must comply strictly with the specification.
- 3.7. Only offers that meet or are greater than the specification will be considered.
- 3.8. Late quotes will not be considered.
- 3.9. Expired product/s will not be accepted. All products supplied must be valid for a minimum period of six months.
- 3.10. A bidder not registered on the Central Suppliers Database or verification has failed will not be considered.
- 3.11. All delivery costs must be included in the quote price, for delivery at the prescribed destination.
- 3.12. Only firm prices will be accepted. Such prices must remain firm for the contract period. Non-firm prices (including rates of exchange variations) will not be considered.
- 3.13. In cases where different delivery points influence the pricing, a separate pricing schedule must be submitted for each delivery point.
- 3.14. In the event of a bidder having multiple quotes, only the cheapest according to specification will be considered. 4. SPECIAL INSTRUCTIONS AND NOTICES TO BIDDERS REGARDING THE COMPLETION OF THIS QUOTATION.

- 4.1. Unless inconsistent with or expressly indicated otherwise by the context, the singular shall include the plural and vice versa and with words importing the masculine gender shall include the feminine and the neuter.
- 4.2. Under no circumstances whatsoever may the quotation/bid forms be retyped or redrafted. Photocopies of the original bid documentation may be used, but an original signature must appear on such photocopies.
- 4.3. The bidder is advised to check the number of pages and to satisfy himself that none are missing or duplicated.
- 4.4. Quotation submitted must be complete in all respects.
- 4.5. Any alteration made by the bidder must be initialled.
- 4.6. Use of correcting fluid is prohibited
- 4.7. Quotation will be opened in public as soon as practicable after the closing time of quotation.
- 4.8. Where practical, prices are made public at the time of opening quotations.
- 4.9. If it is desired to make more than one offer against any individual item, such offers should be given on a photocopy of the page in question. Clear indication thereof must be stated on the schedules attached.

5. SPECIAL INSTRUCTIONS REGARDING HAND DELIVERED QUOTATIONS

- 5.1. Quotation shall be lodged at the address indicated not later than the closing time specified for their receipt, and in accordance with the directives in the quotation documents.
- 5.2. Each quotation shall be addressed in accordance with the directives in the quotation documents and shall be lodged in a separate sealed envelope, with the name and address of the bidder, the quotation number and closing date indicated on the envelope. The envelope shall not contain documents relating to any quotation other than that shown on the envelope. If this provision is not complied with, such quotations/bids may be rejected as being invalid.
- 5.3. All quotations received in sealed envelopes with the relevant quotation numbers on the envelopes are kept unopened in safe custody until the closing time of the quotation/bids. Where, however, a quotation is received open, it shall be sealed. If it is received without a quotation/bid number on the envelope, it shall be opened, the quotation number ascertained, the envelope sealed and the quotation number written on the envelope.
- 5.4. A specific box is provided for the receipt of quotations, and no quotation found in any other box or elsewhere subsequent to the closing date and time of quotation will be considered.

13. PENALTIES

- 13.1. If at any time during the contract period, the service provider is unable to perform in a timely manner, the service provider must notify the institution in writing/email of the cause of and the duration of the delay. Upon receipt of the notification, the institution should evaluate the circumstances and, if deemed necessary, the institution may extend the service provider's time for performance.
- 13.2. In the event of delayed performance that extends beyond the delivery period, the institution is entitled to purchase commodities of a similar quantity and quality as a substitution for the outstanding commodities, without terminating the contract, as well as return commodities delivered at a later stage at the service provider's expense.
- 13.3. Alternatively, the institution may elect to terminate the contract and procure the necessary commodities in order to complete the contract. In the event that the contract is terminated the institution may claim damages from the service provider in the form of a penalty. The service provider's performance should be captured on the service provider database in order to determine whether or not the service provider should be awarded any contracts in the future.
- 13.4. If the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance.

14. TERMINATION FOR DEFAULT

- 14.1. The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:
 - (i) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract,
 - (ii) if the supplier fails to perform any other obligation(s) under the contract; or
 - (iii) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 14.2. In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services.

1.5 Failure on the part of a bidder to submit proof of B-BBEE Status level of contributor together with the quote, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.

1.6 The purchaser reserves the right to require of a bidder, either before a quote is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

2. DEFINITIONS

- (a) **"B-BBEE"** means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- (b) **"B-BBEE status level of contributor"** means the B-BBEE status of an entity in terms of a code of good practice on black economic empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- (c) **"bid"** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods or services, through price quotations, advertised competitive bidding processes or proposals;
- (d) **"Broad-Based Black Economic Empowerment Act"** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (e) **"EME"** means an Exempted Micro Enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;
- (f) **"functionality"** means the ability of a tenderer to provide goods or services in accordance with specifications as set out in the tender documents.
- (g) **"prices"** includes all applicable taxes less all unconditional discounts;
- (h) **"proof of B-BBEE status level of contributor"** means:
 - 1) B-BBEE Status level certificate issued by an authorized body or person;
 - 2) A sworn affidavit as prescribed by the B-BBEE Codes of Good Practice;
 - 3) Any other requirement prescribed in terms of the B-BBEE Act;
- (i) **"QSE"** means a qualifying small business enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;
- (j) **"rand value"** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

3. POINTS AWARDED FOR PRICE

3.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

- Ps = Points scored for price of bid under consideration
- Pt = Price of bid under consideration
- Pmin = Price of lowest acceptable bid

4.1 In terms of Regulation 6 (2) and 7 (2) of the Preferential Procurement Regulations, preference points must be awarded to a bidder for attaining the B-BBEE status level of contribution in accordance with the table below:
