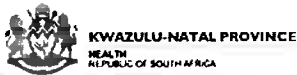

- The Tattoo ink must be 14ml
- The tattoo ink must be non-waterproof.
- The tattoo ink is sterilized
- The tattoo ink have non-hazardous colours
- The tattoo ink must be non toxic, don't cause injury to humans or cause chronic and acute health problems. Certified by Toxicology Advisory Board (ACMI)
- The tattoo ink must have a stamp of approval ("AP"- Approved Product).
- The tattoo must be free from toxic chemicals, PBT and vPvB .
- The tattoo ink boiling point $>100^{\circ}\text{C}$ @760mmHg
- The tattoo ink relative density 1.0 to 1.2 @ 20°C .
