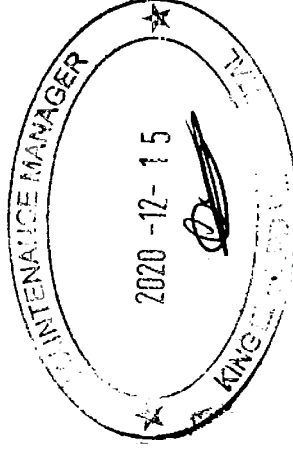
Scope of work

- 1) Find cause of gas leak.
- 2) Fix what caused the gas leak.
- 3) Evacuate system gas pipes to remove all air and moisture from system as per manufactures recommendation.
- 4) Fill the system with manufactures recommended gas type and weight.
- 5) Repair and clean all non-functioning inside building units functioning from this plant to fully functional condition.
- 6) Replace top AHU condenser coil and Blue chem treat cleaned coil to protect against corrosion
- 7) Install primary and bag filters (with new seals) in entire plant where space is provided in all fan units.
- 8) Replace hinges on fresh air fan units with bolt and wing-nut type (M6) Stainless steel arrangement for ease of servicing,
- 9) Replace all door seals and secure.
- 10) Secure all loose covers poprivits type panel nut arrangement and secure with M5 Stainless steel Philips (Head) screws.
- 11) Replace all belts in AHUs and set tension correctly.
- 12) Eliminate all noises that come through air ducts (Mrs. Governder's office and Staff tea room to be specific).
- 13) Clean entire plant.
- 14) Report any other defects discovered for further attention.

- (i) *that the price(s), rate(s) & preference quoted cover all for the work/item (s) & accept that any mistakes regarding the price (s) & calculations will be at the bidder's risk*
- 3.4. The bidder must accept full responsibility for the proper execution & fulfilment of all obligations conditions devolving on under this agreement, as the Principal (s) liable for the due fulfilment of this contract.
- 3.5. This quotation will be evaluated based on the 80/20 points system, specification & correctness of information. All required documentation must be completed in full and submitted.

8. STATEMENT OF SUPPLIES AND SERVICES

8.1. The contractor shall, when requested to do so, furnish particulars of supplies delivered or services executed. If he/she fails to do so, the Department may, without prejudice to any other rights which it may have, institute inquiries at the expense of the contractor to obtain the required particulars.

9. SUBMISSION AND COMPLETION OF SBD 6.1

9.1. Should a bidder wish to qualify for preference points they must complete a SBD 6.1 document. Failure by a bidder to provide all relevant information required, will result in such a bidder not being considered for preference point's allocation. The preferences applicable on the closing date will be utilized. Any changes after the closing date will not be considered for that particular quote.

10. TAX COMPLIANCE REQUIREMENTS

13. PENALTIES

- 13.1. If at any time during the contract period, the service provider is unable to perform in a timely manner, the service provider must notify the institution in writing/email of the cause of and the duration of the delay. Upon receipt of the notification, the institution should evaluate the circumstances and, if deemed necessary, the institution may extend the service provider's time for performance.
- 13.2.
