2. 4. The people with disabilities subcontracted by main contractor must not submit a separate tender document for the same contract number advertised, should they do so, the quotation will be treated as non-responsive and will be disqualified.			
5. The people with disabilities subcontracted by main contractor must submit proof of address from Ward Counsellor or Utility Bill as a proof that they reside within catchment area.			
<b>Tenderer (Bidder) failing to comply with the above will be regarded as non-responsive and immediately be disqualified</b>			
6. The main contractor and subcontracted company must submit valid proof of joint venture agreement signed as an affidavit in front of Commissioner of Oaths.			
<b>Note. We reserve the right to check for validity of the joint venture agreement. Tenderer (Bidder) subcontracting but failing this criteria will be regarded as non-responsive and will immediately be disqualified</b>			
7. The EME and QSE subcontracted must be registered with Central Supplier Database (CSD), have valid tax clearance certificate on Central Supplier Database (CSD). If expired there must be proof of tax clearance certificate which will be checked and verified with SARS via pin number. The CSD proof must be submitted as an addendum if not submitted the quotation will be treated as non-responsive and will be disqualified.
