

1. AMENDMENT OF CONTRACT

Any amendment to or renunciation of the provisions of the contract shall at all times be done in writing and shall be signed by both parties.

CHANGE OF ADDRESS

Bidders must advise the Department of Health (institution where the offer was submitted) should their address (domicilium citandi et executandi) details change from the time of bidding to the expiry of the contract.

GENERAL CONDITIONS ATTACHED TO THIS QUOTATION

The institution is under no obligation to accept the lowest or any quote. 3.1.

The price quoted must include VAT (if VAT vendor). However, it must be noted that the department reserves the right to evaluate all 3.2. quotations excluding VAT as some bidders may not be VAT vendors.

The bidder must ensure the correctness & validity of quote: 3.3.

8. STATEMENT OF SUPPLIES AND SERVICES

8.1. The contractor shall, when requested to do so, furnish particulars of supplies delivered or services executed. If he/she fails to do so, the Department may, without prejudice to any other rights which it may have, institute inquiries at the expense of the contractor to obtain the required particulars.

9. SUBMISSION AND COMPLETION OF SBD 6.1

9.1. Should a bidder wish to qualify for preference points they must complete a SBD 6.1 document. Failure by a bidder to provide all relevant information required, will result in such a bidder not being considered for preference point's allocation. The preferences applicable on the closing date will be utilized. Any changes after the closing date will not be considered for that particular quote.

10. TAX COMPLIANCE REQUIREMENTS

- 10.1. In the event that the tax compliance status has failed on CSD, it is the suppliers' responsibility to provide a SARS pin in order for the institution to validate the tax compliance status of the supplier.

11. TAX INVOICE

12. PATENT RIGHTS

The supplier shall indemnify the KZN Department of Health (hear after known as the purchaser) against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

13. PENALTIES

13.1. If at any time during the contract period, the service provider is unable to perform in a timely manner, the service provider must notify the institution in writing/email of the cause of and the duration of the delay. Upon receipt of the notification, the institution should evaluate the circumstances and, if deemed necessary, the institution may extend the service provider's time for performance.

13.2. In the event of delayed performance that extends beyond the delivery period, the institution is entitled to purchase commodities of a similar quantity and quality as a substitution for the outstanding commodities, without terminating the contract, as well as return commodities

delivered at a later stage at the service provider's expense.

13.3. Alternatively, the institution may elect to terminate the contract and procure the necessary commodities in order to complete the contract. In the event that the contract is terminated the institution may claim damages from the service provider in the form of a penalty. The service provider's performance should be captured on the service provider database in order to determine whether or not the service provider should be awarded any contracts in the future.

13.4. If the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay

14. TERMINATION FOR DEFAULT

BODY BAGS SPECIFICATION

SUPPLY AND DELEIVERY OF BODY BAGS FOR VARIOUS INSTITUTIONS SPECIFICATIONS FOR DISPOSABLE BODY BAGS SIZE INFANT TO XX-LARGE

1. SCOPE

1.1 This specification covers the requirements for the material, cut and make of disposable body bags.

2. MATERIALS

The following materials must be used by the manufacturer:

2.1 Cloth

Recycled plastic with a minimum thickness of not less than 180 microns must be used to make the body bag.

2.2 --- Colour

The body bag must be white including the handles and the zipper must be black.

2.3 Sewing Thread

Size 25 poly-cotton corespun threads must be used to sew the zip. It must have a breaking strength of at least 12 Newton(N) and linear density compatible with the material with which it is used. The body bag should be able to accommodate the body weight of up to 200kg.

2.4 Welding

The plastic panels of the body bag must be heaf bonded together to secure a waterproof joint.

2.5 Slide fastener

The code must be (A 5 CF). Nylon Zip, together with two DFLLK sliders to accommodate a lockable device. The slide fastener must be black in color.

2.6 Handles

The body bag must have 6 extra strong carry handles with a tensile strength of up to 200kgs, suitable for handling by 6 people. All handles to be box stitched using poly-cotton corespun polished 25

REQUIREMENTS

WORKMANSHIP - The workmanship must comply with the requirements for workmanship in specification SANS 1270/2007

3.1 Style

The body bag must be the length and width of the specified size, inside facing and a U-shaped zip with two bokable sliders. The zip will be sewn in 15cm from the edges of the upper part of the body bag.

3.2 Make

All sewing must be in accordance with SABS 0101.
All heat welding must be in accordance with SABS specifications.
The body bag must be leak proof provided the zip is on top.
