- Be made up of 3 parts - plastic with rubber piston
- Be lubricated with silicone gel and well fitted
- Be latex free, non-pyrogenic and DEPH free
- Have clear markings that are not easily removed with spirits
- Allow for permanent marker markings without rubbing off
- Be sterile and individually packed in a peel pouch that is easy to open
- Be for single use only

The following must be noted on the packaging:

- Trade name
- Size and specification
- Method of sterilization
- Manufacturing site
- CE number
- Lot number
- Expiry date
