1.1 This specification covers the requirements for the material, cut and make of disposable body bags.

MATERIALS

The following materials must be used by the manufacturer:

- ➤ Cloth: Recycled plastic with a minimum thickness of not less than 180 microns shall be used to make the body bag.
- **Colour:** The body bag must be white including the handles and the zipper should be black.
- Sewing Thread: Size 25 poly-cotton corespun threads shall be used to sew the zip. It shall have a breaking strength of at least 12 Newton(N) and linear density compatible with the material with which it is used. The body bag should be able to accommodate the body weight of up to 200kg.

- ➤ Slide fastener: The code must be (A 5 CF) Nylon Zip, together with two DFLLK sliders to accommodate a lockable device. The slide fastener shall be black in color.
- ➤ **Handles:** The body bag must have 6 extra strong carry handles with a tensile strength of up to 200kgs, suitable for handling by 6 people. All handles to be box stitched using poly-cotton corespun polished 25 threads.
