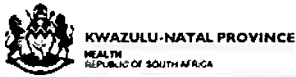

SPECIAL CONTRACT CONDITIONS OF QUOTATIONS 1.1 The institution is under no obligation to accept the lowest or any quote. 1.2 The price quoted must include VAT (if VAT vendor). 1.3 The department reserves the right to evaluate all quotations excluding VAT as some bidders may not be VAT vendors. 1.4 The bidder must ensure the correctness & validity of quote: that the price(s), rate(s) & preference quoted cover all for the work/item (s) & accept that any mistakes regarding the price (s) & calculations will be at the bidder's risk. 1.5 The bidder must accept full responsibility for the proper execution & fulfilment of all obligations conditions devolving on under this agreement, as the Principal (s) liable for the due fulfilment of this contract. 1.6 This quotation will be evaluated specification & correctness of information. 1.7 Only offers that comply with or greater than specification will be considered. 1.8 Late quotes will not be considered. 1.9 All products supplied must be valid for a minimum period of six months. 1.10 A bidder not registered on the Central Suppliers Database or verification has failed will not be considered. 1.11 All delivery costs must be included in the quote price, for delivery at the prescribed destination. 1.12 Only firm prices will be accepted.
