

REPLACEMENT OF MEDICAL AIR COMPRESSORS

AT R.K. KHAN HOSPITAL

SCOPE OF CONTRACT

This specification calls for the replacement of medical air compressors inclusive of electrical supply panels as per attached schedule.

2. DETAILED SCOPE OF WORK- MEDICAL AIR

2.1. Medical air compressors:

- 2.1.1. Strip and remove existing redundant units.
- 2.1.2. Supply and install 2 new Full Feature units.
 - a) Units to be a minimum of 7.5kw screw compressors (Detroit or similar quality)*
 - b) Receiver vessels to be a minimum of 360 Litres each
 - c) Each unit to have incorporated dryers.
 - d) Direct start system although alarms must be indicated in a remote panel/
 - e) Drive type is direct coupled
 - f) Dimensions (mm) approx. Length=1740mm, Depth=600mm, Height=1450mm

*No cheap imported units will be accepted, catalogues to be submitted with the tender documents and will be evaluated accordingly.

2.2. Required Pressures

- 2.2.1. The units must be piped for two systems of medically pure compressed air in general use. System A which is to supply air to operating theatres for use on surgical instruments and System B, which is to supply air for respiratory purposes to wards and theatres.
- 2.2.2. System A units shall be High Pressure Air, regulated between 700 kPa and 800 kPa gauge and System B shall for Low Pressure Air, regulated at 400 kPa gauge.
- 2.2.3. The air shall be free from oil moisture and bacteria.
- 2.2.4. The pressure requirements for respiratory purposes are for use either as a driving gas for respiratory machines, or for air/oxygen mixing.
- 2.2.5. The medical gas keyed probes shall be in accordance with S.A.B.S.1409 1986 (Outlets Sockets and Probes for Medical Services used in Hospitals).
- 2.2.6. The medical compressed air shall be dried by bacterial filtration desiccant driers and refrigerated air driers as detailed in the Project Specification.
- 2.2.7. Starting at the plant room and immediately after the compressor, receiver, driers, filters, etc., the supply line shall be split and pressure reducing valves installed in each leg to produce the required pressure for the low pressure supply lines system B and high pressure lines system A. the pipelines shall each have relief valves to prevent excess pressure build-up in case of regulator failure.

2.3. Medical Air Compressors and Filtration

- 2.3.1. The compressor and filtration system to be used shall produce medically pure "oil free", "moisture free" and "bacteria free" air (reference must be made to the Project Specification).
- 2.3.2. All air compressors shall be of air-cooled Stop Start controlled type.
- 2.3.3. Where a type A installation is required it shall be rated at 1000 kPa gauge working pressure. Units may be two stage compression type.
- 2.3.4. Where a type B installation is specified it shall be rated at 700 kPa gauge working pressure. The output of the compressor and all other requirements shall be as specified in the Project Specification.

2.4. Compressed Air Receivers

2.4.1. The size of the air receiver will be given in the Project Specification.

2.4.2. Two receivers are required. The receiver shall be of welded construction with dished ends, tested and stamped by an Independent Inspection Authority in terms of the Occupational Health and Safety (as amended)

2.4.3. It shall be fitted with a safety valve set at 70 kPa above the cutout point of the mercury control switch and a 75mm diameter dial pressure gauge with gauge cook. The working pressure shall be marked in red. The receiver shall be galvanised internally and externally.

2.4.4. The tank shall be painted with a suitable metal primer undercoat and final enamel coat, colour White with Salmon Pink (A40) colour to S.A.B.S. 1091. The pipe connections to the receiver shall be fitted with sufficient loops and/or offsets to render them sufficiently resilient to absorb vibration.

2.5. Pressure Reducing Valves

- 2.5.1. There shall be two adequately sized pressure reducers in the supply line after the filters, which shall maintain a constant pressure in the line of 800 kPa gauge or 400 kPa gauge for system A and B respectively. The pressure reducer shall be such that it is possible to adjust the pressure by at least 140 kPa each way when required.
- 2.5.2. Pressure reducing valve stations shall be fitted with pressure gauges having dials of not less than 100mm diameter. The gauges are to be marked with red lines at the maximum pressure (on the face).
- 2.5.3. Manufacturer's flow charts must be supplied with the regulators.

2.6. Alarm panels

- 2.6.1. The existing panel may be used to install warning lights and alarms.
- 2.6.2. The alarms shall consist of low air warning with red light indicator and green light indication under normal conditions.

2.7. Certification:

- 2.7.1. Certification must be provided for the calibration of pressure regulators, warning systems and pressure testing of the entire system
- 3. The complete panel must be prefabricated and prewired to reduce/ minimize downtime. A wiring diagram must be provided with the panel.
- 4. Degrease and Paint floors with an epoxy based paint. Walls to be painted with a washable PVA based paint.
- 5. Service providers are to liaise with the hospital maintenance department to arrange for shutdowns.
- 6. Provide routine services for all new equipment installed for a period of one year.

7. NOTE: This estimate form shall be used for Repair work, when the scope of work is not known and only one quotation is obtained. The work done shall be measured on completion and shall be at proven time, travel and costs in accordance with the Contract ZNB5730/2014H Clause B31 to B33

1. AMENDMENT OF CONTRACT

1.1. Any amendment to or renunciation of the provisions of the contract shall at all times be done in writing and shall be signed by both parties.

2. CHANGE OF ADDRESS

2.1. Bidders must advise the Department of Health (institution where the offer was submitted) should their address (domicilium citandi et executandi) details change from the time of bidding to the expiry of the contract.

3. GENERAL CONDITIONS ATTACHED TO THIS QUOTATION

- 3.1. The institution is under no obligation to accept the lowest or any quote.
- 3.2. The price quoted must include VAT (if VAT vendor). However, it must be noted that the department reserves the right to evaluate all quotations excluding VAT as some bidders may not be VAT vendors.
- 3.3. The bidder must ensure the correctness & validity of quote:
 - (i) that the price(s), rate(s) & preference quoted cover all for the work/item (s) & accept that any mistakes regarding the price (s) & calculations will be at the bidder's risk
- 3.4. The bidder must accept full responsibility for the proper execution & fulfilment of all obligations conditions devolving on under this agreement, as the Principal (s) liable for the due fulfilment of this contract.
- 3.5. This quotation will be evaluated based on the 80/20 points system, specification & correctness of information. All required documentation must be completed in full and submitted.
- 3.6. Offers must comply strictly with the specification.
- 3.7. Only offers that meet or are greater than the specification will be considered.
- 3.8. Late quotes will not be considered.
- 3.9. Expired product/s will not be accepted. All products supplied must be valid for a minimum period of six months,
- 3.10. A bidder not registered on the Central Suppliers Database or verification has failed will not be considered.
- 3.11. All delivery costs must be included in the quote price, for delivery at the prescribed destination.
- 3.12. Only firm prices will be accepted. Such prices must remain firm for the contract period. Non-firm prices (including rates of exchange variations) will not be considered.
- 3.13. In cases where different delivery points influence the pricing, a separate pricing schedule must be submitted for each delivery point.

- 5.1. Quotation shall be lodged at the address indicated not later than the closing time specified for their receipt, and in accordance with the directives in the quotation documents.
- 5.2. Each quotation shall be addressed in accordance with the directives in the quotation documents and shall be lodged in a separate sealed envelope, with the name and address of the bidder, the quotation number and closing date indicated on the envelope. The envelope shall not contain documents relating to any quotation other than that shown on the envelope. If this provision is not complied with, such quotations/bids may be rejected as being invalid.
- 5.3. All quotations received in sealed envelopes with the relevant quotation numbers on the envelopes are kept unopened in safe custody until the closing time of the quotation/bids. Where, however, a quotation is received open, it shall be sealed. If it is received without a quotation/bid number on the envelope, it shall be opened, the quotation number ascertained, the envelope sealed and the quotation number written on the envelope.
- 5.4. A specific box is provided for the receipt of quotations, and no quotation found in any other box or elsewhere subsequent to the closing date and time of quotation will be considered.

13. PENALTIES

- 13.1. If at any time during the contract period, the service provider is unable to perform in a timely manner, the service provider must notify the institution in writing/email of the cause of and the duration of the delay. Upon receipt of the notification, the institution should evaluate the circumstances and, if deemed necessary, the institution may extend the service provider's time for performance.
- 13.2. In the event of delayed performance that extends beyond the delivery period, the institution is entitled to purchase commodities of a similar quantity and quality as a substitution for the outstanding commodities, without terminating the contract, as well as return commodities delivered at a later stage at the service provider's expense.
- 13.3. Alternatively, the institution may elect to terminate the contract and procure the necessary commodities in order to complete the contract.
