

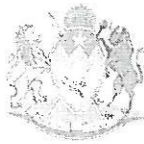

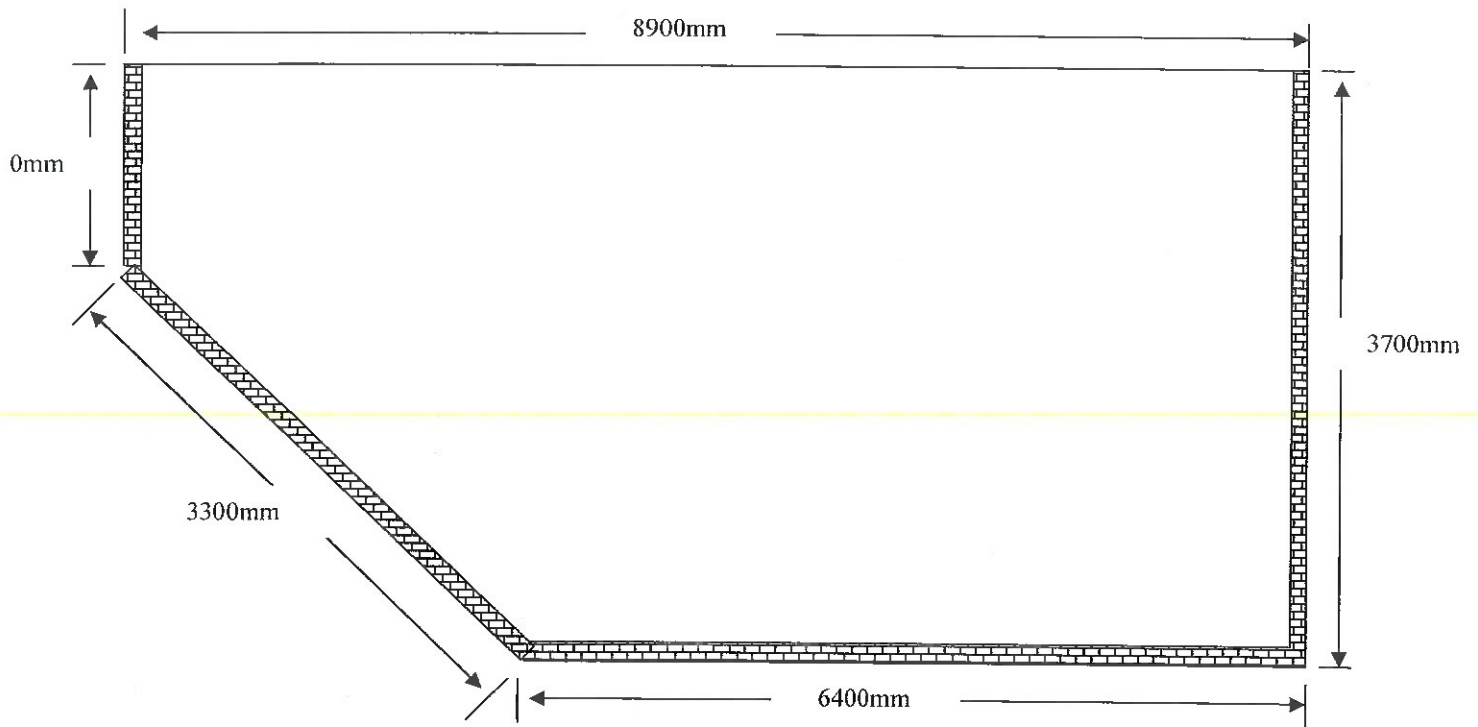
**1. SCOPE OF CONTRACT**

The contract calls for the supply and installation of an awning structure over the pharmacy waste collection area and rodent-proofing of the existing medical waste enclosure, repairs to Card Office awning.

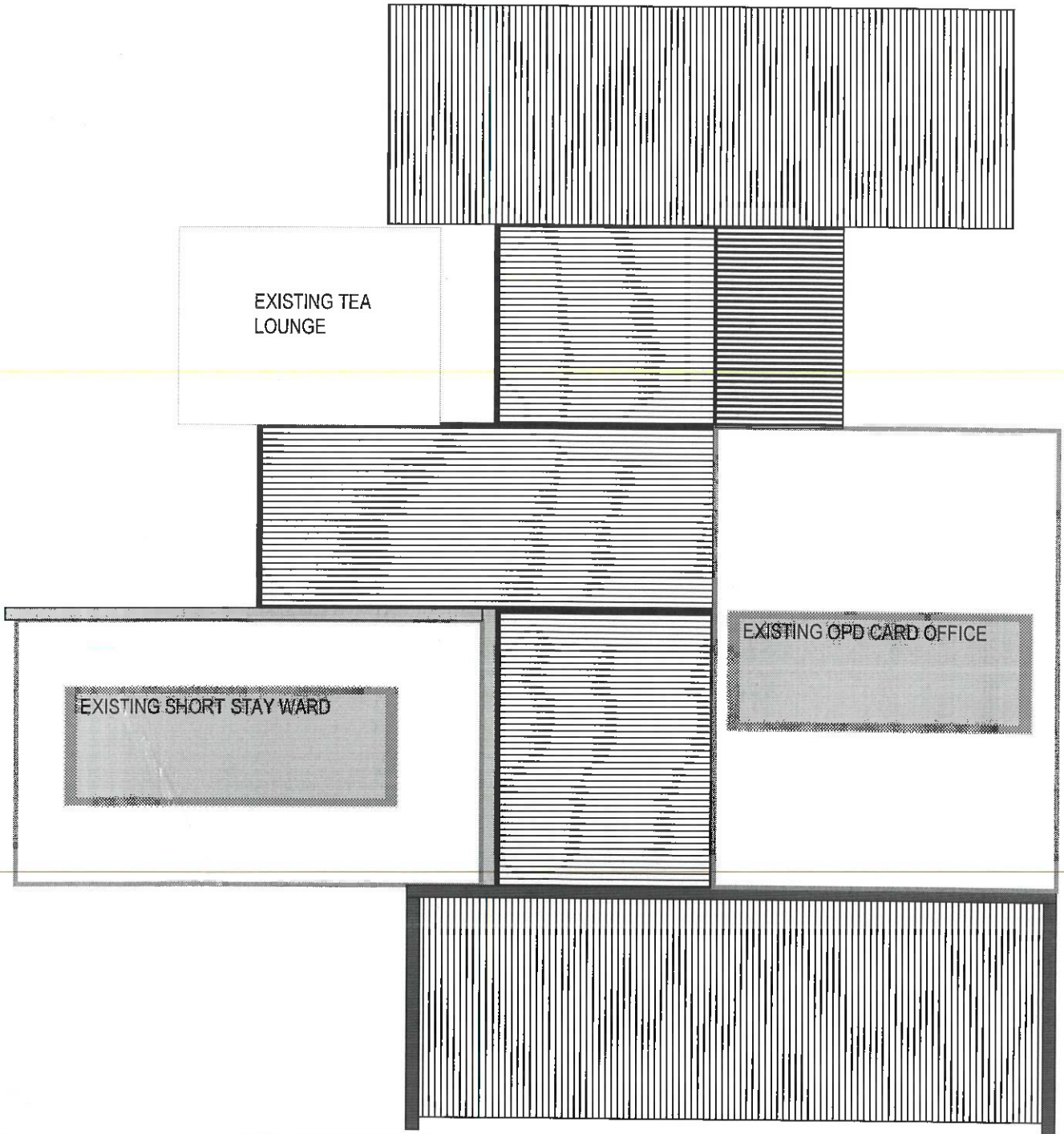
**2. DETAILED SPECIFICATION**

- 2.1. Area of sheeting to be installed is 33 m<sup>2</sup>.
- 2.2. The roof sheeting shall be Zinc-aluminium sheeting industrial **0.58mm** 'Klip Lock 700 or Craftlock (green in colour- colour facing upwards).
- 2.3. All roof supporting cross-members shall be a minimum of 100mm, galvanized channelled steel.
- 2.4. Gutters shall be extruded aluminium epoxy coated type with extruded down pipes discharging into the existing storm water drains.
- 2.5. The gutters are to be fixed to the galvanized cross members.
- 2.6. All sheeting sections fixed against building walls must be properly waterproofed to prevent any leaks.
- 2.7. Method of fixing shall be storm-type clips (no piercing of sheets will be allowed).
- 2.8. **Additional Repairs:**
  - a) **Medical waste area:**
    - Replace mesh wire for rodent control. Wire must be galvanized steel, diamond or square patterned with a maximum aperture of 10mm. Wire thickness to be a minimum of 1mm.
  - b) **Stretcher bay (repairs)**
    - Replace awning sheeting with Zinc-aluminium sheeting industrial **0.58mm** 'Klip Lock 700 or Craftlock , **4 metres x 5 lengths**.
    - Supply and install galvanized mesh wire to wall openings above the stretcher bay. Wire must be galvanized steel, diamond or square patterned with a maximum aperture of 10mm. Wire thickness to be a minimum of 1mm.
  - c) **Card Office (repairs)**
    - Replace awning sheeting with Zinc-aluminium sheeting industrial **0.58mm** 'Klip Lock 700 or Craftlock **as per layout sketch**.
    - Raise existing supports on awning structure 400mm and remount and seal.
    - Supply and install cable tray and attach all loose cables. Cable tray must be a minimum of 300mm in width, perforated and galvanized steel.

- 2.1. Bidders must advise the Department of Health (institution where the offer was submitted) should their address (*domicilium citandi et executandi*) details change from the time of bidding to the expiry of the contract.

### 3. GENERAL CONDITIONS ATTACHED TO THIS QUOTATION

- 3.1. The institution is under no obligation to accept the lowest or any quote.
- 3.2. The price quoted must include VAT (if VAT vendor). However, it must be noted that the department reserves the right to evaluate all quotations excluding VAT as some bidders may not be VAT vendors.
- 3.3. The bidder must ensure the correctness & validity of quote:
- (i) *that the price(s), rate(s) & preference quoted cover all for the work/item (s) & accept that any mistakes regarding the price (s) & calculations will be at the bidder's risk*

If at any time during the contract period, the service provider is unable to perform in a timely manner, the service provider must notify the institution in writing/email of the cause of and the duration of the delay. Upon receipt of the notification, the institution should evaluate the circumstances and, if deemed necessary, the institution may extend the service provider's time for performance.
- 13.2. In the event of delayed performance that extends beyond the delivery period, the institution is entitled to purchase commodities of a similar quantity and quality as a substitution for the outstanding commodities, without terminating the contract, as well as return commodities delivered at a later stage at the service provider's expense.
- 13.3. Alternatively, the institution may elect to terminate the contract and procure the necessary commodities in order to complete the contract. In the event that the contract is terminated the institution may claim damages from the service provider in the form of a penalty. The service provider's performance should be captured on the service provider database in order to determine whether or not the service provider should be awarded any contracts in the future.
- 13.4. If the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance.

### 14. TERMINATION FOR DEFAULT

- 14.1. The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:
  - (i) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract,
  - (ii) if the supplier fails to perform any other obligation(s) under the contract; or
  - (iii) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 14.2. In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services.
- 14.3. Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.
