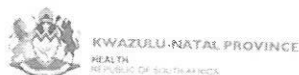

**1. AMENDMENT OF CONTRACT**

- 1.1. Any amendment to or renunciation of the provisions of the contract shall at all times be done in writing and shall be signed by both parties.

**2. CHANGE OF ADDRESS**

- 2.1. Bidders must advise the Department of Health (institution where the offer was submitted) should their address (*domicilium citandi et executandi*) details change from the time of bidding to the expiry of the contract.

**3. GENERAL CONDITIONS ATTACHED TO THIS QUOTATION**

- 3.1. The Department is under no obligation to accept the lowest or any quote.
- 3.2. The Department reserves the right to communicate in writing with vendors in cases where information is incomplete or where there are obscurities regarding technical aspects of the offer, to obtain confirmation of prices or preference claims in cases where it is evident that a typing, written, transfer or unit error has been made, to investigate the vendor's standing and ability to complete the supply/service satisfactorily.
- 3.3. **ALL DECISIONS TAKEN BY THE DEPARTMENT ARE FINAL, INCLUDING THE AWARD OR CANCELLATION OF THIS QUOTATION.**
- 3.4. The price quoted must include VAT (if VAT vendor).
- 3.5. Should a bidder become a VAT vendor after award or during the implementation of a contract, they may not request the VAT percentage from the Department as the service provider made an offer during the period they were not registered as a VAT vendor. The Department is only liable for any VAT from registered VAT vendors as originally stated on the quotation document.
- 3.6. The bidder must ensure the correctness & validity of the quotation:  
 (i) *that the price(s), rate(s) & preference quoted cover all for the work/item (s) & accept that any mistakes regarding the price (s) & calculations will be at the bidder's risk*  
 (ii) *it is the responsibility of the bidder to confirm receipt of their quotation and to keep proof thereof.*
- 3.7. The bidder must accept full responsibility for the proper execution & fulfilment of all obligations conditions devolving on under this agreement, as the Principal (s) liable for the due fulfilment of this contract.

- 4.2. Under no circumstances whatsoever may the quotation/bid forms be retyped or redrafted. Photocopies of the original bid documentation may be used, but an original signature must appear on such photocopies.
- 4.3. The bidder is advised to check the number of pages and to satisfy himself that none are missing or duplicated.
- 4.4. Quotations submitted must be complete in all respects. ## 2 YEAR CONTRACT FOR RECYCLING OF WASTE CARDBOARD, PAPER, PLASTIC, TINS AND GLASS AT RK KHAN HOSPITAL AND RK KHAN GATEWAY CLINIC

### 1. Terms and conditions:

#### 1.1 Specification

- The contractor shall provide the Institution with boxes for paper, plastic, tins, glass which shall be stationed close to offices or designated areas. Cardboard are to be removed from Pharmacy, Main Kitchen and Supply Chain Management daily then stored at the central storage waste area situated in front of Compound.
- The contractor shall be responsible for placing and emptying these boxes on a daily basis.
- The contractor shall collect these boxes and pay for the recycled wasted collected per kg.

#### 1.2 Price

- The contractor shall pay for all waste collected as per quote price immediately after weighing.
- Price will be fixed for the duration of the contract.

#### 1.3 Duration of Agreement

- The provision of the contract shall be effective from 01 October 2022 and shall remain in force for the period of 24 months, period ending 30 November 2024, unless terminated earlier by mutual consent of parties and or unless contract is extended in writing on a month to month basis.

#### **1.4 Obligations of this contract**

- The contracted company manager to conduct monthly site inspection for monitoring of the project.
- All recyclables from the Institution must be done 3 times a week, Monday, Wednesday and Friday.
- The contractor shall provide the Institution with boxes for paper, plastic, tins, glass which will be stationed close to offices or designated areas.
- The boxes must have the company name printed on the boxes.
- Cardboards are to be collected from the central waste storage area.
- The contractor shall be responsible for placing and emptying these boxes.
- A list of allocated areas of placing these boxes will be given to the contractor.
- Confidential or classified information (patient files) must be shredded by the contractor with an accreditation certificate before being transported outside the Hospital premises. **Failure to produce the accreditation certificate will result to disqualification.**
- The contractor must provide a **weighing scale** for recording of recyclables (papers & boxes) collected and waste shall be weighed in the presence of the Institutions representative.
- The contractor shall pay at Revenue Department for all waste collected as per quoted price immediately after weighing.
- Pick up must be done in all storage areas.
- It is the responsibility of the contracted company to ensure that recyclables are kept in storage areas and not all over the place.
- Ensure cleanliness in / around storage areas before and after collection.
- The contracted company must sort and remove the items that need to be recycled according to the planned schedule.
- The company must obtain a gate pass from the Waste Management Officer and sign the register for record purposes upon collection.
- The collection, removal and recycling shall be done in a safe manner and in accordance with all environmental health requirements.
- The service provider shall give a one month notice for any decision to withdraw from the agreement.
- Failure to abide by the above set method, the tender will be disqualified and services terminated.
- Revenue should be rated in percentage not in rand value.

#### **1.5 Obligation of RK Khan Hospital (The Institution) under this contract**

- Ensure that the site is in a serviceable condition.
- The Institution will not offer the categorized waste service to any other service provider while this agreement is still in force.
- The Institution will advise the company of any complaints and notifications that might affect the service.

## 2. Requirement of contract:

### 2.1 Transport

- The contractor must have their own bakkie or truck registered to their company name.
- The contractor must have public liability, should any unforeseen incidents while driving in and around the Institution.

### 2.2 Evaluation criteria

- Complete and signed SBD4 and price page.
- Complete and sign bill of quantity.
- Attach SARS status
- Attach B-BBEE certificate
- Proof of company vehicle to load and remove recycled waste.
- Attach valid public liability.

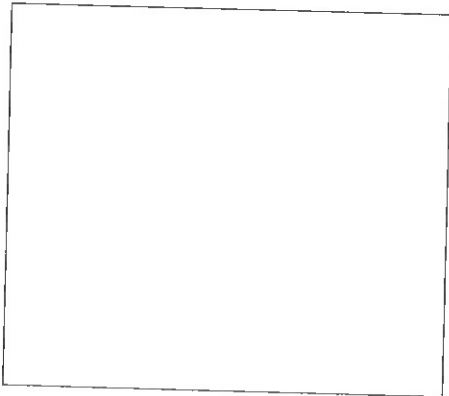

## 11. TAX INVOICE

11.1. A tax invoice shall be in the currency of the Republic of South Africa and shall contain the following particulars:

## 12. PATENT RIGHTS

The supplier shall indemnify the **KZN Department of Health** (hereafter known as the purchaser) against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

## 13. PENALTIES

- 13.1. If at any time during the contract period, the service provider is unable to perform in a timely manner, the service provider must notify the institution in writing/email of the cause of and the duration of the delay. Upon receipt of the notification, the institution should evaluate the circumstances and, if deemed necessary, the institution may extend the service provider's time for performance.
- 13.2. In the event of delayed performance that extends beyond the delivery period, the institution is entitled to purchase commodities of a similar quantity and quality as a substitution for the outstanding commodities, without terminating the contract, as well as return commodities delivered at a later stage at the service provider's expense.
- 13.3. Alternatively, the institution may elect to terminate the contract and procure the necessary commodities in order to complete the contract. In the event that the contract is terminated the institution may claim damages from the service provider in the form of a penalty. The service provider's performance should be captured on the service provider database in order to determine whether or not the service provider should be awarded any contracts in the future.
- 13.4. If the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance.

## 14. TERMINATION FOR DEFAULT

- 14.1. The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:
- (i) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract,
  - (ii) if the supplier fails to perform any other obligation(s) under the contract; or
  - (iii) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 14.2. In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services.
- 14.3. Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.

**2. DEFINITIONS**

- (a) **"B-BBEE"** means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- (b) **"B-BBEE status level of contributor"** means the B-BBEE status of an entity in terms of a code of good practice on black economic empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- (c) **"bid"** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods or services, through price quotations, advertised competitive bidding processes or proposals;
- (d) **"Broad-Based Black Economic Empowerment Act"** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (e) **"EME"** means an Exempted Micro Enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;
- (f) **"functionality"** means the ability of a tenderer to provide goods or services in accordance with specifications as set out in the tender documents.
- (g) **"prices"** includes all applicable taxes less all unconditional discounts;
- (h) **"proof of B-BBEE status level of contributor"** means:
  - 1) B-BBEE Status level certificate issued by an authorized body or person;
  - 2) A sworn affidavit as prescribed by the B-BBEE Codes of Good Practice;
  - 3) Any other requirement prescribed in terms of the B-BBEE Act;
- (i) **"QSE"** means a qualifying small business enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;
- (j) **"rand value"** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

3. POINTS AWARDED FOR PRICE

3.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

$$P_s = 80 \left( 1 - \frac{P_t - P_{\min}}{P_{\min}} \right) \text{ Where}$$

- Ps = Points scored for price of bid under consideration
- Pt = Price of bid under consideration
- Pmin = price of lowest acceptable bid

4. POINTS AWARDED FOR B-BBEE STATUS LEVEL OF CONTRIBUTOR

4.1 In terms of Regulation 6 (2) and 7 (2) of the Preferential Procurement Regulations, preference points must be awarded to a bidder for attaining the B-BBEE status level of contribution in accordance with the table below:
