4.	A tenderer (bidder) must submit Original proof of address from Ward Counsellor or Utility Bill of tenderer (bidder) not less than three months old. Or A Tenderer (Bidder) subcontracting must submit Original proof of address from Ward Counsellor or Utility Bill of tenderer (bidder) not less than three months old. Note: Tenderer (Bidder) failing either of the two criterion will be regarded as non-responsive and immediately be disqualified		
5.	If the Tenderer (Bidder) opted to subcontract a minimum of 30% to an EME or QSE per above, there must be valid proof of joint venture agreement endorsed with South African Police (SAPS) affidavit. Note. We reserve the right to check for validity of the joint venture agreement.
