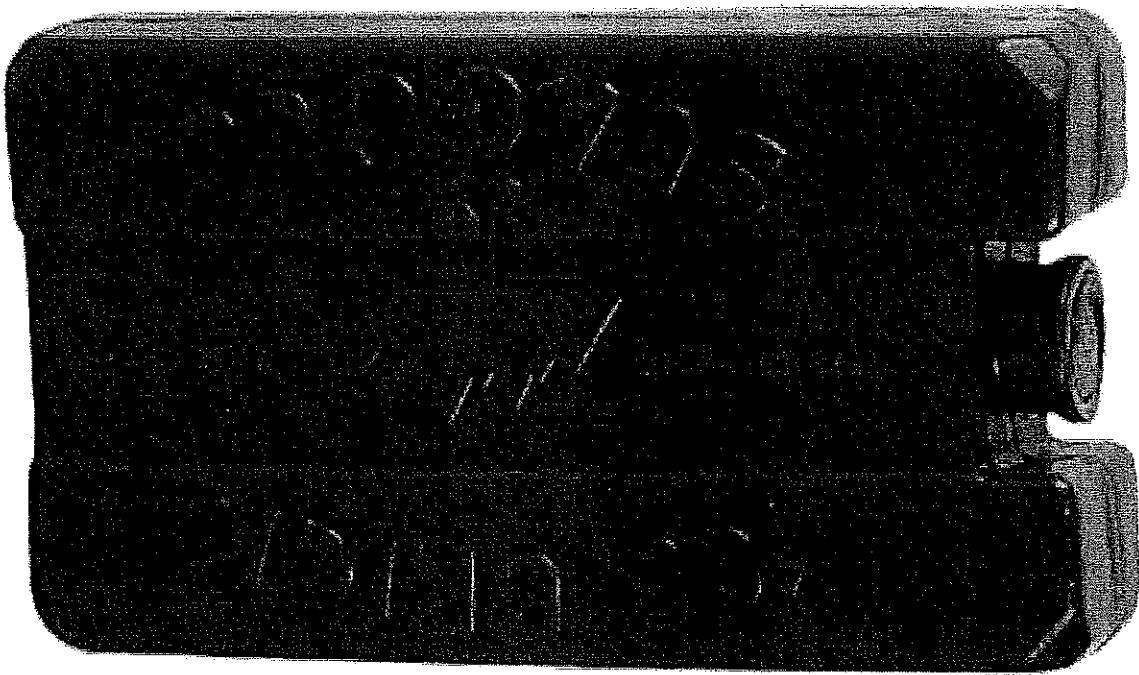

## **WATER (ICE) PACK**

### **TO BE USED AS ICE PACKS IN COOLER BOXES**

- Must be able to be frozen between -5°C and -20 °C
- Robust and puncture-resistant packs
- Must have effective reinforcement to restrain the walls against swelling.
- When water-packs are stacked and frozen in bulk they must not bond together.
- Must be water and vapour proof, must resist UV degradation, easy to clean and must be selected with environmentally safe end of life disposal in mind.
- The product is to be covered by a two-year replacement warranty in the event of any failure arising from defective design, materials or workmanship.
- Must be reusable
