

PART 1

1. GENERAL

1.1 SCOPE OF WORK

- The current scope of work is as per the schedule activities on 8.1 Specifications and BOQ.

1.2 SITE AND MODE OF PROCEDURE

- The site is at Umzimkhulu Forensic Pathology Services at Harry Gwala District in KwaZulu-Natal.
- Bidders are advised that all the existing premises will be occupied throughout the period of any contract.
- Damage to the existing buildings - Bidders to note that any damages done or occurring to any of the buildings will be repaired at the expense of the contractor.
- The service must be done to the satisfaction of the KwaZulu-Natal Department of Health Infrastructure Engineering and Technical Services

1.3 CONTRACT DRAWINGS

- There are no contract drawings issued together with this document.

1.4 REQUIREMENTS (RETURNABLE DOCUMENTS)

- 1ME or above CIDB registration.
- Trade test certificates – refrigeration mechanic (for Artisans).
- Registration with the relevant body (SAQCC under GAS category B).
- Maintenance and repairs experience in the form of CV (personnel within the company).
- Atleast one order and completion letter/certificate for similar scope of work.

NOTE: Failure to submit any of the above documents/information will automatically disqualify the service provider.

PART 2

1. GENERAL TECHNICAL SPECIFICATION

- This Technical Specification is provided as a guideline for bid purposes. The final scope will be discussed during the site briefing.
- After service detailed report to be submitted upon completion of work.

2. STANDARDS

- The operation, construction, material and components of the cold room and freezers and its associated equipment specified, must comply with the latest requirements of:
 - i) The Occupational Health and Safety Act (Act 85, 1993) as amended.
 - ii) SANS 10142: Code of Practice for Wiring of Premises.

3. PROGRAMMING OF WORKS

- The contractor shall notify the institution two (2) days prior to carrying out any site work. As the mortuary is to remain in full operation for the duration of the works, the works are to be planned and executed so as to cause minimum inconvenience to staff. Contractor shall finish this work within two weeks counting from the date when the order number has been issued, unless other strong and valid reason,

4. TESTING AND COMMISSIONING

- The units shall be tested and commissioned before handing over to Department of Health: Provincial Infrastructure Development Engineer. There shall be a commissioning program submitted by the service provider prior to the commissioning and the commissioning shall be witnessed by the Department of Health: Provincial Infrastructure Development Engineer or his/her representatives.

5. SCHEDULE OF EQUIPMENT

UMzimkhulu MLM

- a) 2 x 6 tier body cabinets
- b) 6 split unit air-conditioners

6. REFRIGERATION INTRODUCTION

The refrigeration systems in the forensic mortuaries are used to keep the temperatures of the cold rooms, body cabinets and freezers in the forensic mortuaries at desired low levels to prevent the bodies from decomposing as that can affect the autopsy results.

At Harry Gwala Forensic Mortuaries, the asset information for the coldrooms, freezer rooms, body holding cabinets and split units is as per the Schedule of Equipment.

7. INSTALLATIONS IN HARRY GWALA HEALTH DISTRICTS FORENSIC MORTUARIES

7.1 Refrigeration System

There are four (4) forensic mortuaries at Harry Gwala District and each of these mortuaries has refrigeration system and split units installed.

8. REFRIGERATION SYSTEMS' MAINTENANCE

There are two (2) fundamental types of refrigeration System maintenance that the successful contractor must perform, namely "preventative" maintenance. The contractor must work more towards maximum preventative maintenance, preferable to maintain 80:20 ratio (preventative to reactive) at all times.

8.1 SPECIFICATION (SERVICE ACTIVITIES)

Mortuary Cabinet 1

- Replace evaporator fan motor.
- Replace 2 x latches.
- Replace 2 x hinges.

Mortuary Cabinet 2

- The unit is short of refrigerant due to gas leak, repair leak and regas.
- Replace 2 x latches.
- Replace 2 x hinges.

Mortuary Cabinet 3

- Evaporator fan motor is noisy, replace it.

9. IMPLEMENTING WORK AND REPORTING ON SITE

- 9.1. All contractor employees are required to report to the Facility Manager or his delegated official **upon arrival and prior to departure/upon completion of work.**
- 9.2. Upon arrival and departure (completion of work), all contractor employees must sign the *Contractors Site Visit Register* which will be kept in the facility by the Facility Manager.
- 9.3. A job sheet must be completed on site by the service provider indicating the time worked for a job allocated. The job sheet is to be signed and stamped with a dated facility stamp by the facility manager or his/her delegated official on site. This will be issued to the awarded contractor.
- 9.4. The document required to effect invoice pay-out is as follows:
 - Instruction issued to carry out works on a particular scope.
 - Job sheet, stamped (or signed) and dated by facility manager or his/her designated official.
 - Attendance/site visit register
 - Report on scope executed.
 - Service provider's invoice.

The work will be paid on the basis of time in job sheet and in accordance with the agreed rates.

- 9.5. Report must be sent to the DoH Infrastructure Engineer and the copy to the Facility Manager within 5 days of the works completion.

10. EQUIPMENT TO BE PROVIDED BY THE SERVICE PROVIDER

The service provider shall supply all plant, material, consumables and tools required to carry out the scope of work related to refrigeration maintenance and repairs in the Harry Gwala Forensic Mortuary – Kokstad MLM.

Where a service provider is required to hire plant or equipment which does not form part of their normal refrigeration scope of work, prior approval shall be obtained from the Department's Representative. The name of Department's Representative will be communicated to the appointed contractor.

The works shall be carried out in full compliance to Occupational Health and Safety Act and Regulations and all relevant Acts and standards. All safety precautions required for working on electrical systems shall be taken into account and a risk assessment shall be conducted by the service provider. Suitable personal protective equipment shall be worn at the time of duty. The contractor is fully liable for safety and security of his personnel and shall indemnify the Department of Health for all incidents.
