The bid makes provision as follows :

**Section K: clause 1.1.8 specifies as follows: As a bid submission condition, bidders are required to submit a Compact Disc (CD) containing a scanned copy of the tender offer and accompanying supporting documentation. The evaluation criteria further stipulates that one of the requirements which is compulsory, is the submission of a Compact Disk containing a scanned copy of the tender document.”**
