## **PUBLIC NOTICE**

**WHEREAS**, Section 36 (1) of the National Health Act (61 of 2003, as amended) provides;  
"A person may not-

- (a) establish, construct, modify or acquire a health establishment or health agency
- (c) provide prescribed health services"

Section 36 (6) provides that the Head of Department "may withdraw a certificate of need" or license, "(c) if the health establishment or the health agency, as the case may be, or a health care provider or health worker working within the health establishment, is unable or unwilling to comply with minimum operational norms and standards necessary for the health and safety of users".

**ALSO**, Regulation 6 of the National Health Act (61 of 2003, as amended) provides; "The proprietor of a registered private hospital shall give not less than three months' notice in writing of the intended closure of such hospital to the Head of Department, the Director, patients and staff: Provided that, in exceptional circumstances, the Head of Department may authorise a shorter period of notice."

The Head of Department wishes to notify the public, in terms of the aforementioned prescripts, that licenses of the following private healthcare facilities have been cancelled.
